Dear Coaches and Managers:

Attached is an application for the 21<sup>st</sup> Annual Lakewood Fallfest Soccer Tournament to be held Burns Park in North Little Rock on October 31<sup>st</sup> and November 1<sup>st</sup> 2009. **DEADLINE FOR REGISTRATION IS OCTOBER 13<sup>TH</sup>**. This is strictly a recreational tournament and no guest players or secondary players will be allowed. **Only primary players are allowed to play.**

Teams will be seeded based on this season's record and competition played. Brackets will be posted on our website, [www.lakewoodpoa.com](http://www.lakewoodpoa.com), by October 26<sup>th</sup>. Late registration will result in a \$25.00 late fee added to the entry fee. Entry fees are as follows: U7-U8 \$125.00, U9 -U10 \$175.00, U11-U12 \$200.00, U13 and Up \$250.00. Withdrawal from the tournament after October 16<sup>th</sup> will result in the loss of entry fee. Teams that have not paid their entry fee by October 16<sup>th</sup> will not be included in the tournament. Clubs that enter a group of 8 teams or more will be allowed a discount of \$15.00 per team if they are entered at the same time with one check.

All games will be played at the Burns Park Complex, which does require a \$5.00 parking fee for the weekend. Teams will be required to check in on Friday October 30<sup>th</sup> at the LPOA office, 4500 Lakeshore Drive, from 8:30am to 8:00pm. **All teams must have roster, player cards and medical release when they check in.** Weather permitting; all teams are guaranteed three full-length games with 2 games on Saturday and 1 on Sunday. Due to the number of teams we are unable to schedule all the games on Saturday so there will be a Sunday game. In the past, we have been able to work with those taking the ACT however this year all teams must be able to play their first game by 1:30 for the U16 and above. Your team may pre-order t-shirts and will be available for pick-up when you check-in your teams. Order forms are attached and will be available on our website.
